## SCOTT & CARRIE

Scott DeMuth is a 22-year-old activist from Minneapolis, MN who is being charged with conspiracy under the Animal Enterprise Terrorism Act. AETA is a federal law that broadens “animal enterprise terrorism” to include activities such as civil disobedience and consumer boycotts, as well as more confrontational tactics. He’s being accused of involvement in a 2004 University of Iowa ALF raid, and a 2006 mink liberation in rural Minnesota. Grand jury resister Carrie Feldman spent four months in jail for refusing to testify in front of a grand jury investigating the Iowa raid, and will be speaking about her experience.

The RNC 8 are organizers from Minneapolis, MN, who are being targeted for their involvement in aboveground organizing against the 2008 RNC in St. Paul, MN. For this, they are being charged with conspiracy to riot and conspiracy to commit property damage. The RNC 8 are going to trial on October 25, 2010.

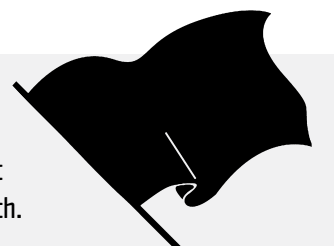
