

### Statement of Probable Cause—Sergeant Michael Canning #2269

My name is Michael Canning and I am currently employed as a Police Sergeant for the City and County of San Francisco, California. I have been so employed as a peace officer for the City and County of San Francisco since February 04, 2013. I am currently assigned to the Bureau of Investigations and detailed to the General Works Unit. My prior assignments include uniformed patrol in the Tenderloin, Ingleside, Southern, Richmond, and Taraval Districts, and investigations for the Special Operations Bureau (MUNI Task Force) and the Special Victims Unit (SVU).

My training includes the Basic San Francisco Police Academy and continuing professional education (Basic, Intermediate, Advanced, and Supervisory Certificates). I have successfully completed the following related courses:

- 80-hour ICI Core Criminal Investigations (POST)
- 24-hour Detective School (SFPD-POST)
- 16-hour Search Warrants, Investigators (POST)
- 16-hour Search Warrants "A to Z" (POST)
- 40-hour POST-Certified Interview and Interrogation



As part of my employment with the San Francisco Police Department, I have conducted hundreds of preliminary and follow-up investigations into a wide variety of crimes, both violent and property-related crimes. These investigations have included documenting police reports; interviewing victims, witnesses and suspects of crimes; and assisting in serving search and arrest warrants. During these investigations, I have obtained information on the means by which these crimes were committed and concealed. I have also worked with and consulted with other veteran law enforcement officers with whom I have had conversations and/or from whom I have received training regarding these types of incidents. My arrests have led to prosecutions where I have testified in Superior Court, and convictions have been obtained as a result of my investigations and testimony.

I am familiar with the facts below based on personal observations, observations by other law enforcement officers shared with me through conversation, written report(s), and from records, documents, and evidence obtained as a result of this investigation. The below information is set forth solely for the purpose of establishing probable cause for the arrest warrant and does not represent all known information concerning this investigation.

#### **Incident Report Summary**

On January 22, 2024, I was employed as a peace officer for the City and County and San Francisco, assigned to the Bureau of Investigations and detailed to the General Work Unit, and tasked with investigating a vandalism incident, memorialized in San Francisco Police Department (SFPD) incident report number 240-038-243.

The following is a brief summary of SFPD incident report number 240-038-243, authored by SFPD Officer Menis #1741:

On January 18, 2024, at approximately 0108 hours, SFPD responded to an alarm activation of (V) The Police Credit Union, located at 2400 Irving Street, within the City and County of San Francisco. Upon arrival, SFPD observed 18 glass windows were damaged by an unknown suspect. The windows appeared to be shattered in the center, but intact where a suspect would not be able to climb inside. The exterior doors of The Police Credit Union did not appear to be tampered with. The ATMs on the

interior and exterior of The Police Credit Union did not appear to be tampered. At the time of this call for service, SFPD was unable to meet and confer with a representative of The Police Credit Union in order to assess and estimate the value of the damaged property.

#### Investigation

#### RP1 Interview

On January 22, 2024, I contacted a representative of The Police Credit Union, RP1. RP1 informed me that there was no structural damage incurred on the property, and no items were stolen from the property. RP1 stated that the only reportable damage was 18 panels of windows which were shattered by unknown instruments. RP1 told me that he does not believe any customers, employees (current or former), are responsible for this act of vandalism.

RP1 informed me that he discovered an online post whose author reportedly took responsibility for the vandalism incident. RP1 later forwarded me the URL link:

https://www.indybay.org/newsitems/2024/01/18/18862190.php

On January 23, 2024, during a subsequent interview, RP1 stated he is in the process of filing a claim with The Police Credit Union insurance company. RP1 estimated the value to repair the 18 panels of glass window to be \$15,000-\$18,000 (parts and labor).

#### RP2 Interview and Video Surveillance Footage

On January 22, 2024, I contacted a representative of The Police Credit Union, RP2. RP2 informed me there was video footage which captured a portion of the incident. RP2 stated that the video surveillance begins recording upon motion activation. RP2 told me that due to this motion activation feature, the unknown suspects were not captured preceding, or following, the act of vandalism. The suspects, however, were captured in the act of shattering the windows.

On January 22, 2024, I responded to The Police Credit Union and recovered the video surveillance footage, which contained two separate video clips.

I reviewed the two separate video clips:

- 1) "SFI2 Outside Rear exit walkway (next to 25<sup>th</sup> Ave)"
  - 12:59:12—S1 is standing on the walkway at the corner of Irving Street and 25<sup>th</sup> Avenue Sanks (southeast corner of building). S1 is wearing a black zip up jacket, black hoody, black baseball cap, black mask covering from S1's nose and chin, black gloves, black pants, black shoes, while wearing a black backpack, and carrying a hammer with a wooden shaft.
  - 12:59:20—S1 motions to S2 using his left hand. Simultaneously, and systematically, S1 struck the windows three (3) times causing the glass to shatter, while S2 struck additional windows.
  - 12:59:23—the video recording stops.
  - 01:11:50—the video recording activates again when the police arrive on scene.
- 2) "SFI2 Outside Walkway CU Logo 25th Ave"
  - 12:58:25—S2 is standing on the southwest corner of the building, on Irving Street at 25<sup>th</sup> Avenue. S2 approaches the window while S1 moves to the southeast corner of the

- building. S2 is wearing a black hoody, black baseball cap, wearing a black backpack, grey/black gloves, black pants, black shoes, and carrying a crowbar.
- 12:58:46—S1 peers around the corner of the building and motions to S2 with his left hand. S2 then peers around the corner of the building, raises the crowbar in S2's right hand, and struck the glass two times. The video recording stops during S2's second strike of the glass.
- 01:08:20—an unknown bystander activates the motion and notices the damage. The video recording stops.
- 01:11:19—the police arrive on scene.

Due to the motion activated setting of the camera, and because of the video surveillance features as described by RP2, this video surveillance footage did not capture the preceding moments prior to, and/or the Suspects flight from, the scene. Furthermore, the video surveillance captured S1 striking the glass window three times, while S2 simultaneously struck the glass window two times.

On January 23, 2024, I received an e-mail from SFPD Officer Grande #302. Officer Grande corresponded with the nearby owners of the following properties: 1279 25<sup>th</sup> Avenue and 1275 25<sup>th</sup> Avenue, within the City and County of San Francisco. It should be noted that a Google Maps query revealed the distance from The Police Credit Union (2400 Irving Street) to 1275-1279 25<sup>th</sup> Avenue is approximately 100 feet.

A resident of 1279 25<sup>th</sup> Avenue provided Officer Grande with an approximate 7-minute video clip. I reviewed the video clip and discovered the following: The video clip captures the front door only; however, an audible sound consistent with glass breaking is heard at the 1 minute and 28 second mark.

A resident of 1275 25<sup>th</sup> Avenue provided Officer Grande with four (4) separate video clips. I reviewed the video clips and discovered the following:

#### Video 1 (00:59 hrs):

S1 and S2 were captured fleeing on the west sidewalk, northbound 25<sup>th</sup> Ave toward Lincoln Ave. S1, and S2 appear to be clothed the same manner as captured on the credit union surveillance. Due to suspects' flight, only a blur is captured.

#### Video 2 (01:09 hrs):

Two unknown subjects are walking side by side on the west sidewalk, northbound 25<sup>th</sup> Avenue toward Lincoln Way. Subject 1 is wearing a backwards-facing baseball cap, unzipped jacket, unknown shirt. pants, shoes. Subject 2 unknown hat/beanie, long sleeve shirt, pants, and shoes. Due to lack of night vision, the color of the suspect's clothing is indiscernible. No backpacks seen on subjects.

#### Video 3 (01:36 hrs):

Two unknown subjects are walking side by side on the west sidewalk, northbound 25<sup>th</sup> Avenue toward Lincoln Way. These two subjects appear to be the same subjects as the video depicted at 0109 hours.

Subject 1 is wearing a forward-facing baseball cap and zip up jacket, pants, and shoes. Subject 2 is wearing an unknown hat/beanie, long sleeve shirt/jacket, pants, and shoes. Due to lack of night vision, the color of the suspect's clothing is indiscernible. No backpacks seen on subjects.

#### Video 4 (01:59 hrs):

Two unknown subjects are walking side by side on the west sidewalk, southbound 25<sup>th</sup> Avenue toward Irving Street. These two subjects appear to be the same subjects as the video depicted at 0136 hours.

Subject 1 (standing on the left side) is wearing a forward-facing baseball cap and zip up jacket, pants, and shoes. Subject 2 is wearing an unknown hat/beanie, long sleeve shirt/jacket, pants, and shoes. Due to lack of night vision, the color of the suspect's clothing is indiscernible. No backpacks seen on subjects.

San Francisco Bay Area Independent Media Center ("Indybay")

On January 22, 2024, I conducted an open-source internet query of the website posting that was forwarded to me by RP1.

I located the article posted on the website, "https://www.indybay.org," which is a website owned and operated by "San Francisco Bay Area Independent Media Center," also known as, "SF Bay Area IMC," also known as, "Indybay."

According to the "About Us" section, I discovered the following:

"The San Francisco Bay Area Independent Media Century is non-commercial, democratic collective of bay area independent media makers and media outlets, and serves as the local organizing unit of the global Indymedia network.

- 1. We strive to provide an information infrastructure for people and opinions who do not have access to the airwaves, tools and resources of corporate media. This includes audio, videous photography, internet distribution and any other communication medium.
- 2. We support local, regional and global struggles against exploitation and oppression
- 3. We function as a non-commercial, non-corporate, anti-capitalist collective.

San Francisco Bay Area Indymedia involves volunteer participants and allied collectives organized san along anti-authoritarian principles of open and transparent decision-making processes, including open public meetings; a form of modified consensus; and the elimination of hierarchies."

According to the "Editorial Policy," I discovered the following:

"The Indybay newswire operates on the principle of open publishing, an element essential to the global Indymedia network. Simply put, open publishing is to news and information what open-source code is to software. In practice, the open publishing newswire allows anyone to instantaneously self-publish their work on <a href="https://www.indybay.org">https://www.indybay.org</a>.

People are encouraged to "become the media," to use their own skills and abilities of observation, writing, and creativity in posting text, video, audio, photos, and artwork directly to the website. The post is then viewable at the top of the breaking newswire."

According to the website, one could subscribe to an e-mail distribution list by creating a username and password (<a href="https://lists.riseup.net/www/subscribe indybay-news">https://lists.riseup.net/www/subscribe indybay-news</a>). This would allow any "Indybay" volunteer to periodically send e-mails which contain "Information on upcoming events," and "A summary and link to recent Indybay feature articles." Furthermore, "The content of 'indybay-news' emails comes exclusively from content already published (by you and your friends) on Indybay."

According to the website, one could "Publish to the Newswire." In order to publish to this open-source public forum, one must fill in a variety of fields, including: Article Title (*required*); Author (*required*); E-mail; Topic; Region; Summary; Website URL; Enter Article Text; Upload Attachments; and

"CAPTCHA" (anti-spam question). Once the user completes the above-mentioned fields of entry, one could, preview and later Publish any article which will then be viewable in the open-source forum.

#### Newswire Article Discovery

On January 22, 2024, I conducted a search query of "SF Police Credit Union," on the Indybay website. I located a published post on the website Newswire, entitled, "SF Police Credit Union Attacked for Tortuguita."

The publishing was posted by an author named, "some anarchists" on "Thu, Jan 18, 2024 1:41AM:"

"In the early hours of January 18, one year after the police murder of Tortuguita, we smashed 18 windows at the San Francisco Police Credit Union as an act of vengeance for it.

We also honor the memories of Kelee Benally, Sekou Odinga, and Banko Brown. Fight for the dea, fight for the living!"

On January 22, 2024, I conducted an open-source internet query of "Police killing of tortuguita." The query revealed a Wikipedia article which described the "Killing of Manuel Esteban Paez Teran, also known as Tortuguita, was a Venezuelan environmental activist and eco-anarchist who was shot and killed by Georgia State Patrol Troopers, after a Georgia State Patrol Trooper was wounded during a raid of the Stop Cop City encampment on January 18, 2023."

#### Conclusion

I know that based on my research of <u>www.indybay.org</u>, "the SF Bay Area IMC web server does not normally track the domains or IP addresses from which people visit and/or post to the SF Bay Area Indymedia web site. Usage of other services, however, *may be logged* (emphasis added).

Due to repeated denial-of-service (DOS)/spam attacks conducted against the SF Bay Area Indymedia website, SF Bay Area IMC may at times log all webserver activity, including client IP addresses. Any such logs will be stored on a RAM disk and discarded within 24 to 48 hours. SF Bay Area IMC reserves the right to send reports of DOS/spam activity to the spammer's internet service provider, and to post them publicly on its website. Only log entries pertaining directly to clear cases of website abuse will be so disseminated and/or preserved.

The SF Bay Area IMC web site contains links to other websites, whether controlled by Indymedia affiliates or unrelated third parties.

Currently, the SF Bay Area IMC uses personal information as a basis for identifying the authors of OF SANTY published articles, and in order to allow individual user login to certain site functions, including ratings and admin. Names (and additional information that a user may choose to post) are publicly available on the SF Bay Area IMC site.

All e-mail sent to the SF Bay Area IMC is stored and accessible to members of Indybay's private email list, including the sender's reported name and e-mail address.

Users may subscribe to receive site notifications, newsletters or other information via email. Users may remove themselves from such services at their discretion.

Users' personal information may be publicly available through a user's published articles. Users have the option to opt out of publicly displaying their real names by typing in a pseudonym; users may choose not to disclose address or telephone contact information at all."

Your affiant believes that the information associated with the above-mentioned published website article URL will assist to verify the internet protocol address, and location of the suspect(s) who created said posting.

#### **Delay of Notification Request**

Your affiant requests that a delayed notification order be granted for this warrant. The focus of this investigation, in its current state, is to identify and arrest the suspect guilty of California Penal Code § 594(b)(1) – malicious mischief, vandalism. If SF Bay Area IMC (Indybay) provides immediate notification to the subscriber upon complying with this search warrant, the suspect(s) involved will certainly become aware that this is a technique used in criminal investigation. Such notification will prompt the suspect(s) to prematurely discard or cease using the subject electronic service provider (ESP) account, electronic device(s), telephone number, or employ countermeasures that will obstruct or severely impair law enforcement from fully executing the Search Warrant requested herein, or making progress in this investigation. Therefore, your affiant is requesting that the ninety (90) days Delay Notification Request be granted.

Your affiant is aware that Penal Code 1546.2 mandates that the law enforcement agency serving this warrant notify the target of the warrant contemporaneously with the service of the warrant unless an order delaying notification is granted. It is further requested, pursuant to the delayed notice provisions of Penal Code 1546.2(b), an order delaying any notification to the target / party that may be required by 1546.2(b) about this warrant, for a period of ninety (90) days.

Additionally, it is further requested that pursuant to the preclusion of notice provisions of Penal Code 1546.2, SF Bay Area IMC (Indybay) be ordered not to notify any person (including the subscriber, customer or owner of the electronic communication or device information to which materials relate) of the existence of this warrant for ninety (90) days.

It is ordered that all information obtained through the execution of the warrant that is unrelated to the objective of the warrant shall be sealed and not subject to further review, use, or disclosure without a court order.

I request that a Search Warrant be issued based upon the aforementioned facts, commanding the search of the person, premise(s) or vehicle(s) designated above for the property or things described, or any part thereof, and that such items or property be brought before this magistrate or retained subject to the order of the court pursuant to Section 1536 of the Penal Code.

## **ORDER**

Your Affiant, Sergeant Michael Canning #2269 requests:

This matter having come before the Court pursuant to an application under Penal Code Section 1524 et seq, which affiants requests that notification of this warrant be delayed. Based upon the reading of the Search Warrant, and Affidavit in Support thereof;

IT APPEARING that there is reason to believe that the notification of the existence of the warrant to any person will result in endanger the life or physical safety of an individual; lead to flight from prosecution; lead to destruction of or tampering with evidence; lead to intimidation of potential witnesses; or otherwise seriously jeopardize an investigation or unduly delay a trial or otherwise lead to an adverse result.

IT IS ORDERED that SF Bay Area IMC (Indybay) shall delay notification of the existence of the application or this Order of the Court, or the existence of the investigation, to the listed subscriber or to any other person, for a period of ninety (90) days unless otherwise directed by the Court.

IT IS FURTHER ORDERED that the notification by the government otherwise required under Penal Code Section 1546.2 (a) be delayed for a period of ninety (90) days.
